STATEMENT OF RESPONSIBILITY

_____, (full name) RG No. or Passport No. _____, by himself, of legal age, hereinafter referred to as **"THE PARTICIPANT"** requests his participation in the **Extremo Sul Ultramarathon 2023** event to be held from NOV 24 to NOV 26, under the following conditions:

The Participant declares and guarantees:

1. Fully accept the test RULES published on the official website.
2. Have full physical and mental capacity to accept and understand the provisions of this term.
3. Be physically and psychologically fit to participate in this EVENT. Enjoy good health, and be aware that there is no medical recommendation that prevents you from practicing physical activity.
4. Be aware of the importance of carrying out a medical control prior to the race.
5. Be cleared by your physician to participate and have trained appropriately for the race.
6. Assume, by their own free will, all risks involved and their consequences for participating in this EVENT (which include the possibility of disability and death), exempting its organizers, collaborators and sponsors from ANY AND ALL LIABILITY for any material, moral or physical damage that he may suffer as a result of participating in this EVENT.
7. Have full knowledge of the course and awareness of the specificities of the race.
8. Present this term in addition to the Medical Certificate available on the official website, duly completed by your doctor, when delivering the kits.
9. Respect the competition rules, as well as the circulation rules and the instructions of those responsible
10. Understand that for safety reasons, the organization will prioritize the attention and evacuation of medical emergencies and urgencies, considering as such those cases that may evolve into a risk of death, which may then require more time to be treated for injuries such as those described above .
11. Do not leave any material at the Supply Bases or with the course staff. The organization is not responsible for objects left outside the Drop Bags.
12. Exempt the Organizers, City Halls and Sponsors from responsibility for loss on the route, personal accidents; damage and/or loss of objects that may occur before, during or after your participation in the test.
13. Authorize that your images in the competition may be used by the Organization and the Sponsoring Companies for purposes of dissemination and publicity of the event and/or products associated with it.

14. Be aware that the Organization may determine the suspension, postponement or cancellation of the race, in whole or in part, without prior notice, for security reasons or reasons of force majeure.

15. Assume that all possible costs related to transportation, preparation, stay, registration, among other expenses incurred by the athlete will be borne solely and exclusively by the athlete, exempting the company responsible for reimbursement of any of these costs.

16. Exempt the Organizers, City Halls and Sponsors from responsibility for contracting any illness that may occur before, during or after their participation in the race.

17. If required, you must submit to the covid test at your expense.
